

IN MEMORIAM – BILL KEARNS

Reflection from Dennis LaLiberty:

All the St. George High School alumni and the many others who knew Bill Kearns lost a good friend on January 15, when Bill Kearns passed away at the age of 91. Bill was a unique individual who lived a life centered around his faith and the good of all people he encountered, both family and a multitude of friends, a great testament to the value of his education at a Christian Brothers school. He always had a positive outlook, forever walking on the sunny side. He never had a bad word to say about another individual and never used bad language, thus he was a wonderful role model for gentlemanly conduct. Many people today can attest to the importance of his mentorship when they were younger and in their formative years.

Not for nothing was Bill Kearns known as "Mr. St. George": No one worked harder than Bill to keep the St. George alumni together and informed about everybody's doings. After graduating in 1950, Bill began his work for St. George as an Assistant Football Coach in the mid-1950's. At about the same time, Bill also coached the football team at Angel Guardian Orphanage (on the site of today's Misericordia Heart of Mercy). He also began producing the Annual St. George Alumni Newsletter about 30 years ago, and it's been growing in popularity ever since. Then, commencing with a simple Christmas season lunch with some buddies from St. George, Bill founded what is today the popular and well- attended annual Saints and Sinners Luncheon. Bill was particularly talented when it came to bringing people together. He and his good friend, Ed Kelly, whom he met when Kelly was in charge of activities at Green Briar Park on Chicago's north side (Kelly went on to become the General Superintendent of the Chicago Park District), were co-hosts of the ROMEO (Retired Old Men Eating Out) lunch group, which meets monthly on the last Thursday at Kappy's Restaurant in Morton Grove. Now Ed will have sole responsibility for the duties of a host, but no doubt Bill will be watching from on high.

Bill Kearns worked tirelessly to foster the togetherness that kept the St. George spirit alive 55 years after the school's closing. And he was doing this good work in his very limited spare time since, even at the age of 87, he was still holding down two jobs as a tennis coach: managing the tennis program for the Wilmette Park District and coaching the Loyola Academy J.V. Girls Tennis Team, jobs from which he retired about two years ago.

Shakespeare wrote, "The evil that men do lives after them; the good is oft interred with their bones . . ." For once, Shakespeare was wrong: The good Bill Kearns did for family and friends will be living after his passing for a very long time in their hearts and memories. Shakespeare was correct in this respect when he wrote, "May flights of angels sing thee to thy rest." R.I.P., Bill.

Reflection from Br. Tom Hetland:

The St. George Dragons lost a giant on January 15, 2024, when the Lord called Bill Kearns, Class of 1950, home to eternal life. For decades Bill was "Mister St. George" when he delivered his annual "State of the Alumni Association" address at the annual alumni banquet in May. Each December for the past many years he helped organize the "Saints and Sinners" Christmas party. For at least 50 years he collected short biographical updates from alumni of all graduation classes

and edited them into a special newsletter booklet, helping alumni keep up with the lives of their fellow Dragons (and occasional Loyola Rambler – Bill was very ecumenical).

Bill was the youngest of six children and is survived by his wife of 70 years, Mary Ann, and their sons Mike, Jim, Kevin, and Larry, along with 9 grandchildren and 18 great-grandchildren.

Given that Bill has passed on and his co-producer of the newsletter, Dennis LaLiberty '55, has retired, this is probably the final edition of this cherished publication. The Dragons are forever grateful to Bill and Dennis for all their efforts and to John Madden '52, the late Joe Madden '50, and the late John Luncsford '54 who contributed the services of their printing companies for many years to make this newsletter available.

Addition from Rev. Patrick Rearden:

Bill, while at St. George, participated in football, basketball and baseball sports. Later, he helped each of these sports for the new freshmen at St. George. Bill, being a good athlete in these sports, wanted to share his talents with youngsters in schools, parishes (like St. Timothy and St. Hilary) and Green Briar Park. His most recent coaching was for tennis at Regina Girls HS and Loyola Academy. Bill was always wanting to give back to others so much that he had received from God.

In recent years, Bill was a daily communicant at St. Peter's Church in Skokie. Before mass, Bill led the Rosary and in the mass was a communion minister. What a great example of a "true Brother's Boy!" May the good Lord be merciful to Bill. He is in our prayers.

Jack's faith played a significant role in his life. He was a charter and lifelong member of St. Mary of the Woods Catholic Church in Chicago. His commitment to his faith was evident in his actions, and he served his community with the same dedication he showed in his professional life. Jack O'Brill lived a life of service, always putting others before himself. His dedication, competence, and kindness were evident in his career, his dedication to his faith, and his love for his family. His legacy will live on in the many lives he touched, both in the classroom and beyond. He will be deeply missed, but his memory will continue to inspire those who were fortunate enough to know him. IN MEMORIAM—BROTHER EDWIN DONALD DUPRE ('49) (b. 7/6/1931 – d.

4/15/2022) Passed away at Resurrection Life Center. A De La Salle Christian Brother for 73 years, he was born in Evanston, IL, son of Donald and Clara (Guirsch) Dupré. He attended St. George H.S. in Evanston and later graduated from La Salle Institute in Glencoe, MO. He entered the novitiate of the Christian Brothers in 1949, pronounced his first vows the next year and his final vows in 1955. He earned a B.A. degree from St. Mary's College in Winona, MN, in 1953. During his years as an educator, he taught at St. Mel H.S. and St. Patrick H.S. in Chicago and served as treasurer for the Christian Brothers in Oak Park and Romeoville and at St. Joseph H.S. in Westchester. From 1979 to 1986 he was a counselor at Mercy Boys Home in Chicago, and he was Development Director at Christian Brothers Center in Romeoville from 1986 to 1998. Survivors include his brother-in-law, Vince O'Reilly; his nephew, Fr. Kevin O'Reilly; and his cousin, Brother Thomas Dupré, FSC, among others, and the De La Salle Christian Brothers. IN MEMORIAM—BOB SMITH ('55) (b. March 1937 – d. 2/16/2023) One of our most distinguished Dragons from the Class of 1955, Bob Smith, 85, passed away on February 16 of this year. Bob died in Guatemala, where he had been living for the last 18 years, devoting his efforts to helping poor families in that country. Bob applied to his charitable endeavors his Christian Brothers education and the Biblical injunction contained in the Book of Matthew, 19-21: "Jesus answered, 'If you want to be perfect, go, sell your possessions and give to the poor, and you will have treasure in heaven."

During his time in Guatemala, Bob became *Padrino* (godfather) for twelve poor families containing about thirty-eight children (it's difficult to make an exact count). The children (many of whom are now adults themselves), who his friends came to know as "Smitty's Kids," called him "Papa Bob," and for good reason. Bob dedicated much of his life to helping these families meet basic human needs and to giving them the opportunity to escape from third-world poverty.

Bob grew up on the Chicago's north side and was educated in the local Catholic School system (St. Hilary, Class of 1951, and St. George H.S., Class of 1955). He was a member of the championship St. George football teams in 1953 and 1954, earning All-State honors as a halfback. (The 1954 team had a "Dream Backfield" consisting of Jack Zachary, LH, Bob Smith, RH, the late Tim Cullinan, FB, and the late John Braun, QB.) Bob received a scholarship to the University of Miami and later transferred to the University of Minnesota, but an injury to his foot cut short his college football career. In 2008 Bob was voted into the Chicago Catholic League Hall of Fame. Bob's involvement with his Guatemalan families began shortly after he retired as a heavy equipment operator in Alaskan oil field construction and maintenance. During his time off from

the oil fields, Bob, who never married, lived with his mother in San Diego. (Bob's parents had divorced when he was in high school and, some years later, his mother, who had remarried, moved to San Diego with her second husband, who passed away during the time Bob was working in Alaska.) In 1994, Bob took an early retirement from the oil fields to take care of his widowed mother, who suffered from kidney disease. Previously, Bob made arrangements to get his father, who had been living in Chicago and who was suffering from heart disease and Alzheimer's disease, transferred to a nursing home in San Diego, so he could care for him.

In the same year of his father's death and Bob's retirement from the oil fields, 1994, he noticed a television ad for the Christian Children's Fund which featured a poor young girl in Guatemala and the headline that your donation could feed her for fifty cents a day. Bob sent a donation and later received from the fund's U. S. office a letter from the girl. In it she told Bob something about her life and the fact that she had five brothers and sisters. Bob was so touched by the letter that he asked the Christian Children's Fund to put him in touch with her directly, but their rules prohibited such contact. Not to be denied, Bob hired an English-speaking private detective in Guatemala who was successful in locating the family. Bob spoke with the parents by phone and for the next eight years stayed in touch by phone and letter. Bob began helping this family directly with funds for things like shoes and clothing, school tuition, and medical needs.

In 2002, after his mother died, Bob was finally able to make a trip to Guatemala to visit the family he had been helping. He spent a month with them over the Christmas season, making the acquaintance of not only this family but other local families and children as well. Returning to the U.S., Bob continued his support of the first family and began to add others as they brought their needs to his attention. With both his parents gone, Bob missed his new extended family so much that in 2005 he made the decision to move to Guatemala permanently.

Over this same period, Bob was dealing with his own physical problems. He had a rare degenerative eye malady, "Birdshot retinochoroidopathy," which caused deterioration of his vision to the point where, ultimately, he could only distinguish between light and darkness but could not see shapes or anything more specific. In 2016, Bob was diagnosed with prostate cancer, which by late 2018 had metastasized into a form of bone cancer, which accounts for his death.

In 2007, some of Bob's friends in the U.S. established a small, private charity entitled "Smitty's Families Charitable Fund" to enable people to support his work with the poor in Guatemala. The fund was shut down in 2022 since most of its mission was completed and because of Bob's declining health situation.

Smitty's financial assistance to the families emphasized education as much as possible, since attaining higher education enabled poor families to escape the vicious cycle of poverty which they would otherwise experience from generation to generation. Smitty's support also helped families with medical expenses, shelter and sustenance. As an example of the value of Smitty's assistance, there are now five grown children of the first family he helped, all of whom have good paying jobs thanks to the higher education they were able to obtain, including specialized training in the English language and development of computer skills. Their jobs include work in a bank, a bilingual call center, and in accounting. Four are now pursuing college degrees part-time in the

evening and funding those expenses themselves. The families Bob Smith symbolically adopted repaid him with much loving and tender care in the final months of a life well lived.

With the passing of its namesake Bob Smith ('55) on 2/16/23 (see entry immediately above) and having essentially completed its mission of providing humanitarian and educational support to some 12 poor families in Guatemala, the fund has been winding down its efforts and is no longer accepting donations, in anticipation of its closing in calendar year 2023. The fund was established 16 years ago, in 2007, to support the good work of the recently deceased Bob Smith, who had been living in Guatemala since 2005 and who had, in a manner of speaking, "adopted" 12 poor families whom he came to know through the Christian Children's' Fund. Dennis LaLiberty, Ed Gleason, Jack Zachary, Dr. Mike McCormack, and Pat Gibbons (all '55), plus Jeff Gottstein ('54), and Bill Kearns ('50), serve as officers or directors. Almost 200 Dragons have contributed to this worthy cause, many of them repeat donors. A total of over \$500,000 has been raised over the years thanks to the kindness of those generous Dragons, and all of it applied to the health and welfare of the family members, with special emphasis on education for their children with the goal of preparing them for lives as self-sufficient adults.

The oldest Catholic high school in the State of Illinois, Saint Patrick HS was founded by the Christian Brothers in 1861. It served boys from the area in which it was located, Des Plaines and Adams Streets. Later, as the city continued to grow, industry developed around the school and the students came instead from more outlying areas, thus the decision was made to move Saint Patrick High School to its present location to serve the needs of Catholic boys from the northwest side parishes. These days, St. Patrick students reside in the city of Chicago and nearby suburbs; they represent 51 zip codes and come from more than 100 different elementary schools (4% of the school's students emigrated from other countries).

Classes in the new Saint Patrick began in September 1953. The ensuing years witnessed many improvements to the school's campus, including the addition of new buildings and remodeling of old ones, for example, in 1991, the top floor of the "round" building was reconfigured to accommodate a high-tech Computer Learning Center. Later, in July, 2000, a 6.5 million-dollar construction and program expansion project was completed, including the Lowell A. Stahl Cultural Centre, the James J. Barrett Center, the 299-seat Stahl Family Theatre, the Wallner/Kaulentis auxiliary gym, additional music and art facilities, and additional office space.

Besides the inherent relationship as a Christian Brothers school, there are also many other ties that bind St. Patrick close to St. George: Dr. Joseph Schmidt ('63) served a distinguished 50+ year career at St. Patrick until his retirement in 2021: first, Business Teacher; then Dean of Students; next, Principal; and, finally, President. Paul Quinn ('66) taught there for 41 years; the late Mr. Hilary Kokosinski, who taught at St. George, later became the Principal at St. Patrick; the late Tom Buscarini ('57) both taught and coached at St. Patrick, as did the late Pete Schmit ('40), who earlier had done the same at St. George. In addition, there were numerous Christian Brothers who logged time at both St. George and St. Patrick, including Brother Peter Donlan (Moderator of the St. George Alumni, who oversaw our annual reunion until he passed the "Banquet Baton" to Paul Quinn), and Br. David Galinski (who is still there after more than 50 years, now as a full-time guidance counselor).

Twenty-four years ago, our St. George Alumni Association initiated the Max Burnell Tuition Assistance Program with the goal of helping worthy St. Patrick scholars to enjoy the benefits of a Christian Brothers education. To date, the program has provided a total of \$197,801 in the form of financial assistance grants to students who have a connection to family members who attended St. George HS.
